



REQUEST FOR PROPOSAL - PKN/2/002673/24

Dear Sirs,

On behalf of ORLEN S.A., ORLEN Południe S.A. and ORLEN Oil Sp. z o.o. Purchasing Team we would like to invite your company to submit an offer for deliveries of vegetable oils in the 2024 – 2025 season.

The Request for Proposal concerns deliveries to the following Companies: ORLEN Południe S.A., ORLEN S.A. and ORLEN Oil Sp. z o.o.

For the purposes of this Inquiry, the requirements for all Companies (so-called general) are not marked - they apply to ORLEN Południe S.A., ORLEN S.A. as well as to ORLEN Oil Sp. z o.o.

The specific requirements applicable only to the ORLEN Południe S.A. are marked with the abbreviation (OPD), the specific requirements applicable only to the ORLEN S.A. with the abbreviation (ORL), and the specific requirements applicable only to the ORLEN Oil Sp. z o.o. with the abbreviation (OO).

We encourage you to submit bids to all Companies, however, you may submit bids to only one or selected Companies.

Below we present the details of the Request for Proposal - RFP.

I. SUBJECT OF THE REQUEST FOR PROPOSAL AND CONDITIONS:

ORLEN Południe (OPD)

- **Product:** Certified vegetable oils meeting the Sustainability Criteria, i.e. meeting the requirements of one of the certification systems recognized by the European Commission, in accordance with the requirements set out in this Inquiry, with parameters consistent with the quality specification (Annex 9), including:
 1. Rapeseed oil with phosphorus content up to 300 ppm and/or 70 ppm (Annex 9.1)
 2. Sunflower oil with phosphorus content up to 10 ppm (Annex 9.2)
 3. Soybean oil with phosphorus content up to 300 ppm (Annex 9.3)
 4. Refined Soybean oil with phosphorus content up 10ppm (Annex 9.4)
- **Volume:** OPD's estimated demand is ~ 280,4 kt, including:
 - ~ 186,4 kta of Rapeseed oil 300ppm
 - ~ 74 kta of Rapeseed oil 70ppm

In the summer period, i.e. 01/05 - 31/08/2025, instead of rapeseed oil 300 ppm, it is possible to purchase alternative oils in the amount of ~ 20 kt (total for the entire summer period), including:

~ 4 kt of Sunflower oil 10 ppm

~ 16 kt of Soybean oil 300/10 ppm

- **Delivery basis and place of delivery:** DDP Trzebinia.

In justified cases, it is possible to organize transport by the Buyer - only with the consent of the ORLEN Południe S.A.

- **Means of transport:** railway and/or trucks (for trucks, a limit of ~ 3 kt per month in total for all oil Suppliers).
- **Delivery period:** October 2024 - September 2025
- **GHG emission:** In accordance with Annex 11 attached to the RFP, i.e.:

Where emissions from transport and distribution for rapeseed oil (Etd) are declared as a "partial default value", we confirm that the sum of emissions from all other components (Eec, EI, Ep, Eu, Esca, Eccs, Eccr) will not exceed **985** [kgCO_{2eq}/dry tonne]

Where emissions from transport and distribution as well as from cultivation for sunflower oil (Etd, Eec) are declared as a "partial default value", we confirm that the sum of emissions from all other components (EI, Ep, Eu, Esca, Eccs, Eccr) will not exceed **200** [kgCO_{2eq}/dry tonne]

Where emissions from transport and distribution for soybean oil (Etd) are declared as a "partial default value", we confirm that the sum of emissions from all other components (Eec, EI, Ep, Eu, Esca, Eccs, Eccr) will not exceed **920** [kgCO_{2eq}/dry tonne]

- **GMO:** Required confirmation that the offered oils do not contain GMOs and have not been produced from seeds of genetically modified plants (GMO) in accordance with Appendix No. 12.

ORLEN S.A.

- **Product:** Certified Rapeseed oil with phosphorus content up to 3 ppm meeting the Sustainability Criteria, i.e. meeting the requirements of one of the certification systems recognized by the European Commission, in accordance with the requirements set out in this Inquiry, with parameters consistent with the quality specification (Annex 14).
- **Volume:** ORLEN's estimated demand for Rapeseed oil 3 ppm is ~ 7 kt
- **Delivery basis and place of delivery:** DDP Płock.

In justified cases, it is possible to organize transport by the Buyer - only with the consent of the ORLEN S.A.

- **Means of transport:** Railway Tank Cars with a "gas pendulum" (bottom unloading) with connection ends: 5.5" thread (without modifications, temporary connections).
- **Delivery period:** March 2025 - September 2025
- **GHG emission:** The supplied oil must meet the sustainability criteria set out in Art. 29 section 2-7 of Directive 2018/2001/EC of the European Parliament and of the Council of 11 December 2018 on the promotion of the use of energy from renewable sources.

The expected maximum emission level for the rapeseed oil is presented in two positions/items, i.e. the first one with a maximum emission level of 870 kg CO_{2eq}/dry tonne, the second one with a maximum emission level of 900 kg CO_{2eq}/dry tonne. The guaranteed emission level should be determined by the Bidder in accordance with Annex 16 attached to the RFP, respectively, for the given item(s).

ORLEN Oil Sp. z o.o.

- **Product:** Refined Rapeseed oil - meeting the requirements of this RFP, including among others formal and technical criteria, with quality parameters in accordance with the ORLEN Oil specification attached to the Request for Proposal (Annex 18)
- **Volume:** ORLEN Oil's estimated demand for Refined Rapeseed oil is ~ 48 t.
- **Delivery basis and place of delivery:** DDP Jedlicze, Orlen Oil sp. z o.o., ul. Trzecieckiego 14, 38-460 Jedlicze.
- **Means of transport:** trucks. Rapeseed oil deliveries will be made, based on the order sent to the Supplier, by the Seller's road tankers equipped with fittings enabling efficient unloading, i.e. drain hoses and a compressor.
- **Delivery period:** October 2024 - September 2025 (deliveries only in selected months in accordance with the ORLEN Oil order)
- **GHG emission:** no requirements
- **Oil sample:** in order to verify the quality of the offered oil, before submitting the offer, it is required to send a sample of refined rapeseed oil in the amount of 1 liter to the following address:

II. METHOD OF SUBMITTING OFFERS:

Bidders are requested to submit bids only via Connect Purchasing Platform.

The Purchasing Process is available on the Platform under the name: "Oleje roślinne dla GK ORLEN w sezonie 2024-2025 / Vegetable oils for the ORLEN Group in the 2024-2025 season", purchasing process no.: PKN/2/002673/24

In order to submit an offer by Bidders who are not yet registered on the purchasing platform of ORLEN Group – CONNECT, it is necessary to set up an account on the registration page of the Connect Purchasing Platform
(link: <https://connect.orklen.pl/app/register/start>).

Each offer must consist of a formal and commercial part.

A formal offer should include the documents and statements referred to in point III of this Inquiry.

The commercial offer must contain all the elements referred to in point IV of this Inquiry.

Bidders are not allowed to modify the content of the attachments.

Bidders may enter comments on the attachments (if necessary), which, however, must be clearly marked and initialed, in a manner visible to the Evaluation Team.



III. FORMAL OFFER - FORMAL AND TECHNICAL CRITERIA

General criteria applicable to all Companies (ORLEN Południe, ORLEN, ORLEN Oil) have no markings.

All Bidders must confirm the general criteria (without markings) regardless of whether they submit their offer to all Companies, selected Companies or only one of the Companies.

Formal and technical criteria specific only for a given Company are marked with the Company's symbol (OPD – ORLEN Południe, ORL – ORLEN, OO – ORLEN Oil).

In case of submitting an offer to only one of the Companies or selected Companies, for a Company or Companies to which your offer does not apply, please select 'no' in the criteria.

16. I attach confirmation of submitting VAT-7 declarations for the last 6 months - JPK_V7M (only Polish suppliers).

18. I attach to the offer a printout from the Central Register of Beneficial Owners.

20. I confirm the Bidder's activity in trade in vegetable oils, min. 2 years and/or positive history of cooperation with the ORLEN Group - applies to trading companies/intermediaries.

- 43. OO: I accept Annex 18 - ORLEN Oil quality requirements for refined rapeseed oil.
- 44. OO: I confirm sending a sample of refined rapeseed oil in the amount of 1 liter to the ORLEN OIL Sp. z o.o.

If the above-mentioned formal and technical criteria are not met or the provided offer does not contain the required elements, the Purchasing Team may ask for the missing data to be supplemented as part of the additional enquiry. If the indicated deficiencies are not supplemented, the Bidder's offer may be rejected.

IV. COMMERCIAL OFFER - COMMERCIAL CRITERIA

The commercial offer must contain the following elements:

- a) Validity of the Offer: expected till 30.09.2024
- b) Payment term:
 - OPD: expected 30 days after delivery date
 - ORL: expected 30 days after delivery date
 - OO: expected 60 days from the date of correctly issued invoice

Payment resulting from future invoices will be made in the split payment mechanism (SPLIT PAYMENT), referred to in the Act of March 11, 2004 on tax on goods and services (consolidated text: Journal of Laws of 2020, item 106, as amended).
- c) Volume flexibility at the Buyer's option:
 - OPD: expected +/-20%
 - ORL: expected +/-20%
 - OO: expected +/- 1 truck (~25 tons) for rapeseed oil
- d) Offered volume in tonnes.
- e) The following price components (OPD, ORL, OO):
 - FCA premium/discount to FOB Rotterdam quotations per 1 tonne of oil; expressed in EUR
 - cost of transport to the indicated place of delivery for 1 ton of oil; expressed in EUR
 - DDP premium/discount to the indicated place of delivery for 1 ton of oil; expressed in EUR

V. METHOD OF EVALUATION OF OFFERS (CONNECT)

The criterion for evaluating offers that meet the formal and technical criteria: the lowest discounted DDP or FCA price with the cost of transport (i.e. the net price of the delivered goods) taking into account the FCA/DDP premium/discount offered and the cost of money over time resulting from the payment term.

VI. METHOD OF VALUATION OF GOODS (DELIVERY)

The net price of the delivered goods will be valued according to the following rules:

1. For deliveries in DDP formula:

$$Ct = (FOB \text{ Rotterdam} + P + T) * K$$

 - ORLEN Południe S.A. / ORLEN S.A.: in the month of delivery (expressed in Euro to two decimal places);
 - ORLEN Oil: in the month preceding the delivery (expressed in Euro to two decimal places).
- **P** - means a fixed premium to the FOB Rotterdam quotation per 1 tonne of oil (expressed in Euro).
- **T** - means the cost of transport to the indicated place of delivery for 1 tonne of oil (expressed in Euro).
- **K** - means the average NBP exchange rate for EUR/PLN calculated as the sum of the average daily EUR/PLN quotations at the NBP divided by the number of trading days for the period:
 - OPD / ORL: in the month of delivery (rounded to four decimal places);
 - OO: Euro currency or the average exchange rate of the NBP on the day preceding the day of issuing the invoice.

2. For deliveries in FCA formula:

$$Ct = (FOB \text{ Rotterdam} + P) * K$$

where:

- **Ct** - means the net price for 1 tonne of oil of the quality in accordance with the Inquiry - price for the month of delivery.
