**DECLARATION of No Capital Links, No Grounds for Exclusion from the Procedure, and Confirmation of the Proposal Requirements**

I declare that

has no capital or personal relationships with the Ordering Party - .....

A capital or personal relationship means a mutual relationship between the Ordering Party or persons authorized to incur liabilities on its behalf, or persons performing activities on its behalf related to the preparation and conduct of the contractor selection procedure on the one hand, and the contractor on the other, consisting in particular of:

- participation in the company as a partner in a civil law partnership or commercial partnership,
- owning at least 10% of shares, unless a lower threshold is required by law,
- serving as a member of the supervisory or management board, proxy, or attorney,
- being married, related by blood or marriage in the direct line, related by blood or marriage in the collateral line up to the second degree, or related through adoption, guardianship, or custody,
- being in cohabitation with the Bidder, its legal representative, or members of the management or supervisory bodies of the Bidder applying for the contract,
- being in such a legal or factual relationship with the Bidder that raises reasonable doubt as to impartiality or independence in connection with the procurement procedure;

In addition, the Bidder declares that:

- The price includes a lump-sum remuneration for all duties of the future Contractor necessary for the execution of the subject of the contract,
- Delivery will be made no later than 31.08.2026.
- it has reviewed the Request for Proposal and its annexes and raises no objections, and it has obtained all necessary information to prepare its proposal,
- the offered products are fully compliant with the requirements of the Ordering Party as specified in the description of the subject matter of the contract,
- it acknowledges that it is bound by this proposal for a period of 60 days from the proposal submission deadline,
- for the contractor and its subcontractor(s) with whom it will cooperate in the execution of the subject matter of the contract (if any), there are no circumstances:
  - described in Article 7(1) of the Law of April 13, 2022, on special solutions to prevent support for aggression against Ukraine and to protect national security,
  - described in Article 5k of Council Regulation (EU) No. 833/2014 of July 31, 2014 concerning restrictive measures in view of Russia's actions destabilizing the situation in Ukraine (OJ. of Laws

EU No. L 229, 31.07.2014, p. 1), as amended by Council Regulation (EU) No. 2022/576 amending Regulation (EU) No. 833/2014 concerning restrictive measures in view of Russia's actions destabilizing the situation in Ukraine (OJ. of Laws EU No. L 111, 8.04.2022, p. 1, as amended).

- The Bidder consents to the processing of its personal data for purposes necessary for the bid selection process, in accordance with the Act of May 10, 2018 on the Protection of Personal Data (Journal of Laws of 2018, item 1000), and with Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, repealing Directive 95/46/EC,
- the persons signing the Proposal Form are authorized to submit a proposal on behalf of the Bidder.
- Finally, the Bidder declares under penalty of criminal liability that the documents attached to the Proposal accurately reflect the actual state of affairs, current as of the date of submission (Article 233 of the Criminal Code).
